For myself, heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "successors") I HEARBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, PROMISE NOT TO SUE AND INDEMNIFY the sponsors of this event, the organizations, property owners, law enforcement agencies, all public entities, special districts, and properties of their respective agents, officials, and employees through or by which the events will be held (collectively "the released parties") FROM ANY and all rights and CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASED PARTIES' OWN NEGLIGENCE, which I have or may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to and return from the event.
